NEW EMV CHIP DEBIT CARD COMING SOON

CTCU will soon be issuing EMV Chip Debit Cards. Your next card will be smarter and more secure than ever.

We have made the decision to issue chip cards to all of our cardholders. When your present card expires, you will receive the new chip card, coming in 2016. The new card will arrive in the mail. Members opening new accounts will receive a chip card at the time of issuance. If you would like a new EMV Debit Card issued sooner than your expiration date, please stop in a branch to request one free of charge.

An embedded computer chip in each chip card adds a new layer of security to point-of-sale and ATM transactions when used in chip-enabled card readers. These cards help protect cardholders and merchants from fraud because the chip gives every transaction a unique code that can't be used again.

Chip cards have already been in place in many countries around the world and have been shown to reduce point-of-sale fraud.
